Financial Arrangements & General Procedures

Payment Information -- 1/3 deposit is due when the wedding date is booked, unless other arrangements are made. The balance is due one week prior to the wedding. This deposit guarantees your date and is not refundable in the event of a cancellation, unless it can be rebooked.

High Res DVDs may be purchased for \$250.

Travel Fees for events outside of Santa Cruz County. Up to 50 miles: \$50, 50-100 miles: \$100. Please ask for a quote if over 100 miles.

DVD Storage -- I will store your images in my files for 2 years after the date of your wedding. I will try to notify you upon the two-year anniversary and offer them for purchase. If I do not hear from you, or if you are not interested, I will dispose of them.
